Conditions for participation

What's EcoProfit Novi Sad 2012?

EcoProfit is a program designed for the industrial sector as well as service companies. The goal is to save environmental related costs and reduce the environmental impact at the same time. The program has already been performed in many towns and regions all over Europe. In 2011 EcoProfit has been introduced in Novi Sad successfully for the first time in Serbia.

How does it work?

The first step consists in an initial review, which is a half- day analysis in the company focusing on the economic and ecological potentials for improvement. After the initial review 6 workshops with the participants of various companies are held in a period of 8 month. The companies get the knowhow to use resources and raw materials more efficiently, to optimize production processes, to prevent waste, to meet the legal regulations efficiently, to get funding - and much more. The workshops, as a platform for the exchange of experience in environmental matters, offer an additional benefit for the companies.

Parallel to the workshops experienced EcoProfit consultants guide the companies to identify and realize concrete improvement measures. The EcoProfit-method is implemented in the companies step by step: Environmental data is collected and analyzed. Saving potentials are detected. Measures for improvement are planned, evaluated and realized.

EcoProfit Novi Sad include the following services:

- Initial review to check the economic and ecological potentials for improvement
- 6 full day workshops for 1-2 participants of each participating company
- Provision of workshop-material
- Max. 6 days of individual consultancy by an environmental expert who assists in implementing measures to reduce the company's environmental impact and costs
- PR-activities for all participating companies

Conditions for participation:

- The participating company must not be in bankruptcy- or clearing proceeding.
- The participating company should not be about to be sold or terminated.

- The participating company designates an adequatly qualified person (sufficient english language skills, advanced MS excel user, member of the management) who:
 - will be responsible for the project,
 - who will become the contact person for the consultant and Novi Sad officials,
 - who takes part in the workshops and
 - makes sure that the improvement measures are realised in the company
- The participating company nominates a EcoProfit-team that supports the person responsible for the project.

The participating company supports the EcoProfit method in the company providing personell and financial resources.

Timetable

Dates of all workshops will be announced by the programm management. Dates for individual consulting will be arranged between the consultant and company.

Confidentiality

All consultants commit themselves to privacy concerning all company information (even to officials).

Award

The companies present their EcoProfit measures to a evaluating commission, who decides if the company meets the EcoProfit-critera and is awarded with the EcoProfit-certificate.

Payment conditions

The payment of the participation fee has to be handled within 2 weeks after signing the formal contract between the company and denkstatt.

The participation fees for the companies are set according to the number of employees as shown in the following table:
