For the purpose of this call, landscaping and construction shall mean the remodeling, adaptation and/or construction of commercial, sporting, cultural, entertainment, tourist, congress, exhibition, marketing, catering and /or business infrastructure at the area of the mouth of the Danube-Tisza-Danube Canal. The landscaping and construction can be done in the area bordered on the east and south by the Danube-Tisza-Danube Canal and the Danube river, while the defensive line on the so-called "špic" was made in the form of a quay wall, and an earth embankment was built on the north side of the Danube-Tisza-Danube canal.

For illustrative purposes, the conceptual designs awarded at an appropriate architectural competition for a pedestrian-infrastructure bridge over the Danube-Tisza-Danube Canal and a business and catering facility located at the mouth of the Danube-Tisza-Danube Canal into the Danube are shown below.

The conceptual designs presented are for illustrative purposes only and are not binding on the Interested persons. In other words, the Interested persons are free to propose alternative solutions, which may encompass a completely different concept of landscaping and construction in the area of the mouth of the Danube-Tisza-Danube Canal into the Danube.

Following an analysis of the Letters of Interest received, the competent authorities of the City of Novi Sad may initiate an appropriate procedure for landscaping and construction at the mouth of the Danube-Tisza-Danube Canal into the Danube. The analysis of the Letters of Interest received will be carried out by a working group formed by the City of Novi Sad. The goal of the City of Novi Sad is to improve the quality of life of the local population by attracting investments and creating new jobs, in this case through the regulation of the Danube-Tisza-Danube mouth into the Danube, access roads, bicycle and pedestrian connections with the green and other free surfaces in this area.

The Letter of Interest must contain the following information:

- General information about the Interested person (business name, registered office, company registration number and VAT identification number);
- Financial offer the proposed amount of investment in landscaping and construction in the area of the mouth of the Danube-Tisza-Danube Canal into the Danube;
- Framework Business Plan;
- Outline conceptual design for the implementation of the investment program (which should include the indicative amount of planned investments, as well as the plan, manner and dynamics, i.e. timeframe for the implementation of the investment program) for landscaping and construction at the mouth of the Danube-Tisza-Danube Canal into the Danube;
- Planned structure and method of financing (e.g. financing from own resources, loans and/or subsidies, etc.).
